The Wisconsin Clean Marina Program provides critical information and technical assistance to Wisconsin's marine industry to promote clean and safe waterways. It is a statewide program for marinas that adopt best management practices to protect Wisconsin's water resources.

These practices include preventing and cleaning up fuel spills, providing proper storage and disposal of chemicals and hazardous waste, recycling, reducing stormwater pollution, improving boat maintenance practices and offering boater education.

Wisconsin's certified Clean Marinas have met federal and state pollution and safety laws and have adopted practices that make Wisconsin's waterways cleaner and safer for boaters to enjoy. Certified Clean Marinas are recognized as environmentally responsible businesses.

## Clean Marinas

- Keep oil, fuel, paints, cleaning products, plastics and nutrients out of the water.
- Create a safer and healthier place to work and recreate.
- Contribute to the local and regional economy.
- Enhance the positive image of the community.
- Help boaters prevent the spread of aquatic invasive species.

## ECONOMIC IMPACT OF WISCONSIN'S MARINE INDUSTRY

- Wisconsin has an estimated **149 marina businesses**, accounting for over **\$310 million in economic activity**. (Association of Marina Industries, U.S. Marina Industry Economic Impact Study, 2017)
- **61% of Wisconsinites boated** at least once in 2019. (Wisconsin DNR)
- An industry analysis found that a Wisconsin marina can **contribute up to \$1-4 million to the local economy**. (Findings based on Michigan State University's Recreational Research Center Recreational Boating Economic Impact Tool, data collected between 2008-10.)
- In 2021, Wisconsin's outdoor recreation economy in 2020 contributed \$7.8 billion with **boating and fishing bringing in \$529 million**. (Department of Tourism, Office of Outdoor Recreation)
- Since 2006, Wisconsin continues to have **more than 630,000 registered boats**. More than 1 in 10 state residents own a registered boat. (Wisconsin DNR)
- **Anglers spend \$1.5 billion fishing** in the state annually. (American Sportfishing Association)
- Wisconsin is a key state in outdoor recreation manufacturing, including Mercury Marine the world's leader in outboard engines.
